**Victim #1:** Mohammad Reza Sadeghzadeh, 67 yr-old, Milpitas resident  
**Suspect #1:** Unknown race male, black "hoodie", blue jeans , white mask  
**Suspect #2:** Light skin male, black "hoodie", blue jeans, black mask  
**Suspect #3:** African-American male, black "hoodie", black pants, black/white gloves

On 09/08/12, at approximately 2:13 a.m., Milpitas Police Department officers responded to 1496 N. Milpitas Blvd (7-11 Store) to a report of an injured subject down inside the business. When officers arrived on scene, they found a male employee with a gunshot wound. The victim was pronounced deceased at the scene. Detectives responded to the scene and determined the homicide occurred during the commission of a robbery.

The victim was identified as Mohammad Reza Sadeghzadeh, a 67-year old Milpitas resident, who was employed as the 7-11 night clerk.

Video surveillance from the store revealed 3 males, armed with handguns, entering the store wearing hooded sweatshirts and confronting the victim. The photos provided were taken from the video.
