Assault w/ Deadly Weapon and Felony Vandalism

On October 3, 2014 at approximately 12:54 A.M., the Milpitas Police Department received numerous 9-1-1 calls regarding a fight, involving multiple people with baseball bats, in the carport area on the 1600 block of Adams Avenue. Within a minute and half, multiple Milpitas Police Officers arrived on Adams Avenue and found three victims and two vandalized vehicles. One victim was suffering from a broken left arm.

Victor Manuel Gonzalez was detained after fleeing the scene and in his vicinity was a baseball bat. Gonzalez was identified as one of the suspects. During the course of this investigation, Milpitas Police Officers developed information identifying Mario Ramirez and Julio Ramirez as the other two suspects. Both Mario Ramirez and Julio Ramirez were located and arrested.

Victor Manuel Gonzalez was booked into jail for assault with a deadly weapon, conspiracy, and felony vandalism. Mario Ramirez and Julio Ramirez were booked into jail for assault with a deadly weapon and conspiracy.

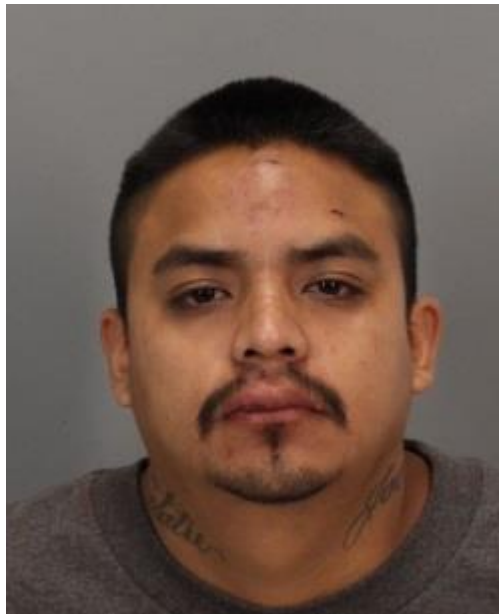

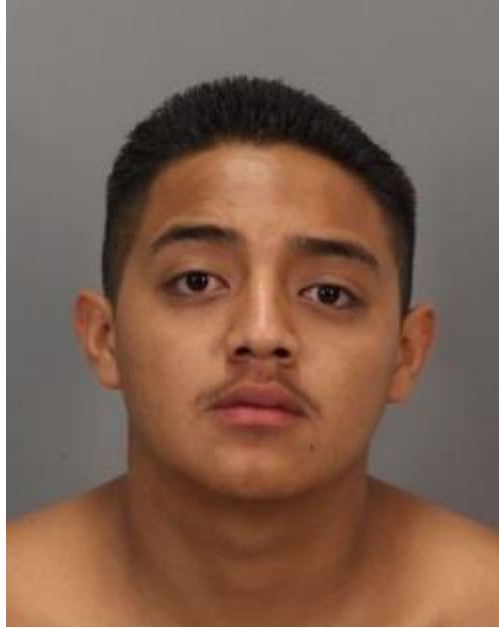
