POSSESSION OF METHAMPHETAMINE FOR SALES

On September 29, 2015 at approximately 9:02 A.M., Milpitas Police Department officers attempted a warrant service at an apartment on the 200-blk of Selwyn Dr. The Officers contacted the listed eight suspects at the apartment. During the course of the investigation it was determined Juventino Soria, Carlos Alberto Gonzalez and Richard Montosa had warrants for their arrests. Officers located three grams of methamphetamine and drug paraphernalia in the living room. Thirty grams of methamphetamine and items associated with narcotics sales were found in a bedroom.

Pablo Garcia Becerra was arrested for possession of methamphetamine, being under the influence of a stimulant and possession of drug paraphernalia. Richard Alexander Montosa was arrested for possession of methamphetamine, possession of drug paraphernalia and two outstanding warrants. Richard Javier Cavillo was arrested for possession of methamphetamine and possession of drug paraphernalia. Felix Bilducia was arrested for possession of methamphetamine and possession of drug paraphernalia. Kayla Jacklyn Kelly was arrested for possession of methamphetamine, being under the influence of a stimulant and possession of drug paraphernalia. Juventino Soria was arrested for possession of methamphetamine for sales and an outstanding warrant. Esther Yvonne Sisneros was arrested for possession of methamphetamine for sales. Carlos Alberto Gonzalez was arrested for possession of methamphetamine for sales, being under the influence of a stimulant and an outstanding warrant. All eight suspects were booked into Santa Clara County Jail.
