ORDINANCE CLAUSE:

THE CITY COUNCIL OF THE CITY OF MILPITAS DDOES ORDAIN AS FOLLOWS:

Traffic Ordinance No.43.207

Section 1.

- A. Chapter 100, Title V, (Traffic) of the Milpitas Municipal Code is hereby amended in the following particulars. Except as expressly amended herein. Chapter 100, Title V of the Milpitas Municipal Code shall be as heretofore enticed and amended.
- B. Section V-100-15.06 of the Milpitas Municipal Code titled, “ Parking Time Limited on Certain Enumerated Street” is amended to read as follows:

Delete the following subsections:

- .3 (On the west side of South Main Street commencing at the end of the curb return north of West Curtis Avenue and extending north for a distance of 57 feet.)
- .4 (On the west side of South Park Victoria Drive commencing at the projected south curb line of Big Basin Drive and extending southerly for a distance of 90 feet.)

Amend the following subsection:

- .5 A five (5) minutes parking zone in front of the Library Parking Lot facing the main entrance.

Add the following subsections:

.8	Thompson St.	East Side from Machado St. to Great Mall Pkwy	4 Hours	7 am – 8 pm
.9	Alvarez Ct.	Entire Section	4 Hours	7 am – 6 pm

Section 2. Effective Date and Posting

In accordance with Section 36937 of the Government Code of the State of California, this Ordinance shall take effect and be in force thirty (30) days from and after the date of its passage. The City Clerk of the City of Milpitas shall cause this Ordinance to be published in accordance with Section 36933 of the Government Code of the State of California.
