A JOINT RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MILPITAS AND REDEVELOPMENT AGENCY OF THE CITY OF MILPITAS APPROVING INITIAL ACCEPTANCE OF BALL PARK FENCE FIELD EXTENSION, PROJECT NO. 5064

WHEREAS, the City of Milpitas has heretofore entered into a contract with Central Fence, Co., for the extension of foul line fencing at the Sports Center ball fields and installation of fan protection covers at Dixon Landing Park, and the City Engineer of the City of Milpitas has recommended acceptance of said improvement as completed in accordance with plans, specifications and approved change orders and correction lists, and in accordance with the final inspection of said City Engineer.

NOW, THEREFORE, BE IT RESOLVED that the City Council and Redevelopment Agency of the City of Milpitas does hereby accept said improvement as completed on this _____ day of _____, and does hereby authorize and direct the City Engineer of the City of Milpitas to file a Notice of Completion in accordance with the provisions of Section 3093 of the Civil Code of the State of California, and does hereby authorize and direct the City Engineer to file a Certificate of Completion in accordance with the provisions of Section 4005 of the Government Code of the State of California, if said work was by day’s labor or force account. The penal sum of the faithful performance bond securing said improvement may be reduced to the sum of \$9,616.38 upon request of principal and surety, said penal sum as reduced to apply from the date of completion and acceptance of said improvements and to extend for the balance of the term of said bond, provided that said term shall not be less than one year.

7. Said work of improvement was accepted by the Milpitas City Council as completed on **June 5, 2007**


