

RESOLUTION NO. _____

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MILPITAS DECLARING CERTAIN PROPERTIES TO CONSTITUTE A NUISANCE AND FIXING THE TIME AND PLACE FOR OBJECTIONS TO ABANDONMENT

WHEREAS, the Santa Clara County Agricultural Commissioner advised the City of Milpitas that it had complied its annual list of properties declared to constitute a nuisance due to an overgrowth of weeds; and

WHEREAS, the Santa Clara County Agricultural Commissioner will individually notify the owners of those properties of its intent to abate said nuisance and assess the cost as a lien against said properties if the owners do not abate the nuisance themselves; and

WHEREAS, the purpose of this resolution is to fix a time and place where the said property owners can object to the proposed abatement.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Milpitas that:

1. January 15, 2008, at 7:00 p.m., in the Council Chambers at City Hall, Milpitas, California, shall be the time and place set aside for owners of properties listed on the Santa Clara County’s annual list of properties declared to constitute a nuisance due to an overgrowth of weeds to voice any objections they may have to the proposed nuisance abatement by the Santa Clara County Agricultural Commissioner; and
2. The City Clerk is hereby authorized to cause notice of this resolution be given to the Office of the Santa Clara County Agricultural Commissioner Weed Abatement Section.
