

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MILPITAS APPROVING FINAL ACCEPTANCE OF SINGLEY AREA STREET REHABILITATION PHASE IV (SANTA RITA DRIVE), & ANNUAL STREET RESURFACING 2006 (LOMER WAY & HOLLY WAY), PROJECT NO. 8181 AND PROJECT NO. 4229, AND RELEASING IMPROVEMENT BOND

WHEREAS, certain improvements were installed in Singley Area Street Rehabilitation Phase IV (Santa Rita Drive), & Annual Street Resurfacing 2006 (Lomer Way & Holly Way), Project Nos. 8181 and 4229 under and pursuant to the provisions of an improvement contract between the City of Milpitas, a municipal corporation of the State of California, and Alaniz Construction, Inc (contractor); and

WHEREAS, said (contractor), as principal, and the Contractors Bonding Insurance Company as surety, executed a certain faithful performance bond conditioned upon the faithful performance of the provisions of said improvement contract and upon the faithful performance of all improvement work required thereunder; and

WHEREAS, said improvements were completed, finally inspected by the City Engineer of the City of Milpitas, and accepted; and

WHEREAS, a period of one year or more has expired after the date of said acceptance of said improvements; and

WHEREAS, the City Engineer has advised said City Council that said (contractor) has remedied, restored, repaired, or replaced at his sole expense and to the satisfaction of said City Engineer all defects, damages, or imperfections, if any there were, due to or arising from faulty materials or workmanship and appearing within said period of one year from the date of acceptance; and

WHEREAS, said City Engineer recommends to the City Council of said City, that said faithful performance bond be released.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Milpitas as follows:

That the certain performance bond furnished by the above named (contractor), as principal, and the above named surety in connection with those certain improvements for the above designated project, is hereby released and discharged; provided, however, that nothing herein contained shall in any way be deemed to be a waiver, release or relinquishment by City of any obligations imposed upon the contractor or his surety, or sureties, by law or by the above referred to improvement contract, save and except those obligations specifically mentioned herein.


