

The power and beauty of Dutta's technique is in his use of color and texture to give volume to the figures, the fluidity of lines and strokes to depict sensuality of the forms, and his ability to internalize experience and express it in a style that is delightfully refreshing. The cornerstone of his art is the restoration of silence, which he describes as "a quality of amazement that we feel in the presence of the world, and an attendant ability to surrender ourselves before its enchantment." Dutta's ability to juxtapose contrary emotions, the real and imaginary and the known and unknown, makes his art not only a form of self-expression but a reflection of the collective unconscious. His paintings derive their impact both from their details and from the subtle yet furious undercurrent of cool, logical analysis that sweeps them up to tantalizing heights.

Sobhan was born in India in 1970 and moved to USA in 1999. He received his Bachelor of Fine Arts from the Government College of Art and Craft and his Master of Fine Arts from the Rabindra Bharati University, Calcutta. He has participated in several exhibitions across the world, and his works are in several




On the border, Acrylic on Canvas
