A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MILPITAS APPROVING THE PURCHASE OF TASER GUNS AND ACCESSORIES FROM PROFORCE LAW ENFORCEMENT

WHEREAS, Section I-2-3.13 of the Milpitas Municipal Code authorizes the City Council to approve the standardization of supplies or services based on the determination of the Purchasing Agent that the standardization of supplies and materials to be used in public works projects will provide a significant cost savings to the City; and

WHEREAS, on March 6, 2008, the City Council approved Taser International Products as the standard brand of tasers and associated products for the City of Milpitas; and

WHEREAS, Section I-2-3.09 of the Milpitas Municipal Code authorizes the City Council to award contracts without competition when the Purchasing Agent determines that there is only one source for the required supply or service; and

WHEREAS, after conducting a good faith review of the available sources for Taser International Products, the City’s Purchasing Agent has determined that ProForce Law Enforcement is the sole distributor of Taser International Products in California.

NOW, THEREFORE, the City Council of the City of Milpitas hereby finds, determines, and resolves as follows:

1. The City Council has considered the full record before it, which may include but is not limited to such things as the staff report, testimony by staff and the public, and other materials and evidence submitted or provided to it. Furthermore, the recitals set forth above are found to be true and correct and are incorporated herein by reference.
2. That the City Manager is authorized to purchase from ProForce Law Enforcement, as a sole source for the procurement, eighteen (18) Taser International Stun Guns, sixteen (16) Taser Cam Audio Video Recording Units, and two (2) USB Camera Down Load Kits for an amount not-to-exceed \$22,986.07.
