







To whom it may concern:

I am a family member of and a friend to current inhabitants of mobile homes. It has come to my attention that there will be a hearing on Tuesday, May 29, 2009 regarding the City of Milpitas Zoning Ordinance Title XI, Chapter 20, and 10-64. As a concerned citizen, I highly object to the passing of this amendment; I do not believe it will be beneficial to those forced out of their homes. My main argument against this amendment is that, unless the compensation is adequate for all inhabitants of mobile homes, many will not find housing soon enough, or will not be able to live comfortably out of the mobile homes.

I realize that several of my concerns have already been voiced at the community meetings, but I would like to reiterate that finding a new, suitable home can be a difficult task. I consider the location of the mobile homes to be something valuable to those living in them. For example, a senior citizen - who cannot find a home where it is safe and convenient, and who is dependent upon those who live close to the mobile homes - may relocate into a dangerous environment if forced to do so.

I believe the repercussions of amending the City of Milpitas Zoning Ordinance Title XI, Chapters 20, 10-64 are ultimately far more disastrous than beneficial. It is my sincerest hope that the Zoning Ordinance Amendment will be overturned.
