A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MILPITAS CONFIRMING A WEED ABATEMENT REPORT AND ASSESSMENT LIST TO BE ENTERED ON TAX ASSESSMENT BILL

WHEREAS, on December 2, 2008, the City Council of the City of Milpitas adopted Resolution No. 7804 declaring noxious or dangerous weeds growing upon certain described property to be a public nuisance that must be abated by the removal of the weeds; and

WHEREAS, if the public nuisance was not removed from the properties by the owner, the City contracted the County Department of Agriculture and Resource Management Office of the County Fire Marshal to remove the weeds and abate the nuisance; and

WHEREAS, the County Department of Agriculture and Resource Management Office of the Fire Marshal filed a report and weed abatement assessment list with the City Clerk in conformance with Title V, Chapter 202 of the Milpitas Municipal Code; and

WHEREAS, on August 4, 2009 a public hearing was held on said report and assessment list, a copy of which is attached hereto as Exhibit A.

NOW, THEREFORE, the City Council hereby finds, determines, and resolves as follows:

1. The City Council has considered the full record before it, which may include but is not limited to such things as the staff report, testimony by staff and the public, and other materials and evidence submitted or provided to it. Furthermore, the recitals set forth above are found to be true and correct and are incorporated herein by reference.
2. The City Council hereby confirms the 2009 Weed Abatement Assessment by the County of Santa Clara for the City of Milpitas, filed by the County Department of Agriculture and Resource Management Office of the Fire Marshal, without modification; and
3. The City Council finds that the said assessment list report is hereby remanded to the County Department of Agriculture and Resource Management Office of the Fire Marshal to be entered on the tax assessment rolls as provided by Title V, Chapter 202 of the Milpitas Municipal Code.
