Sumeet Ahuja is currently an Associate Director of Product Management at AT&T Mobility's core Messaging and Data Products team that is responsible for a multi-billion dollar revenue stream. This team is also responsible for concept, strategy and implementation of AT&T's emerging consumer services in the mobile and cloud space. Sumeet has been part of AT&T Mobility since 2009 and has been instrumental in the launch of AT&T's cloud-based Contact Management solution and a Messaging service.
