1. City Streets, Parks and Facilities Naming SOP Review

Background: The City Council’s prior Facilities Naming Subcommittee developed Standard Operating Procedures (SOP) in 2006 to help guide them in naming City parks, streets and facilities. Staff has provided a copy of the SOP’s in the subcommittee packet for review and updating.

Recommendation: Review prior Facilities Naming Subcommittee Standard Operating Procedure and update.

2. Park Naming – Montague Village Park & 450 Montague Park

Background: Two housing developers are requesting names for their neighborhood parks. Prior to the formation of the Facilities Naming Subcommittee the Parks, Recreation and Cultural Resources Commission had reviewed both parks and made recommendations on potential names.
