1. Park Naming – Traverse Park

Background: The subcommittee is requested to consider approval for a name for a new Park, currently referred to as “Traverse Park.” The Parks, Recreation and Cultural Resources Commission had reviewed this park and made a recommendation on the potential name.

- 1) Augustus Rathbone (First Storekeeper, 19th Century)

The Subcommittee requested that the Commission review the name of James “Jimmy” Chamoures, a community member who was instrumental in the rebuilding of the Milpitas Post Newspaper in the mid 90’s. The Commission voted to recommend the original name of Augustus Rathbone for the Park.

Recommendation: Review and discuss park name and make recommendation for final City Council approval.
