A. Presentation by (MCEE) Milpitas Community Education Endowment

The **Milpitas Community Educational Endowment (MCEE)** is a non-profit organization dedicated to supporting Milpitas public schools. Our mission is to partner with parents, the Milpitas Unified School District, and the community to raise funds for providing educational opportunities for all students in the district. Our goal is to make dreams come true through education for all of our students. As we are in our infancy, we are working on becoming a 501c3 nonprofit organization shortly. As an endowment, we strive to become a permanent funding source for our public schools in Milpitas. We hope that you will join and support us in this endeavor.

B. Neighborhood Adoption Program:

At its meeting on February 3 and April 7, 2010, the CAC discussed the implementation of a permanent/pilot program to encourage residents to adopt a portion of their neighborhood or other area's such as blighted residential or commercial and graffiti for beautification purposes.
