Ms. Spuller stated the CPPW and Climate Action Plan are in progress

Ms. Spuller shared a proposed bicycle rack design for The District, Building One mixed used project located on McCandless Drive. Ms. Spuller stated looking at the Milpitas Bikeway Master Plan; this design is not the preferred design.

Chair Stanojevic stated it looks like a bike store rack and the

Commission Faupell stated [the design] is okay to double the amount of bike parking but should not take the place of required bike parking because people can not put their bikes in it.

He suggested the roll up bikes is already a stretch for using.

Commissioner Pablo stated commuting bikes are heavy.

Another suggested location for double racks is in an apartment complex

for shorter.

Commissioner Leon stated that the higher rack would probably not be used.

Ms. Spuller will notify the applicant that the proposed design is not preferred by the BPAC.

Ms. Spuller distributed a draft work plan which included the following highlights:

These were all discussed together in a round table forum.

Commissioner Leon was wondering if "Share the Road" signage can be installed up Calaveras Road near the corners for blind spots. Locations up to the City limits as much as possible.

Commissioner Faupell added after Downing is the bad part. He also added that the County Roads and Airport received funding to improve county road;

Sierra Road was one of the roads on the listing to improve.

Commissioner Faupell restated the Dixon Landing Road/I-880 striping is bad and deteriorating even though it is not in the [City's schedule]. This is a major bicycle commuting route.

Commissioner Pablo stated the buckling at Yosemite Drive near the Railroad tracks is still not attended to.

He also requested striping on S. Milpitas Blvd. There is enough room to place a bicycle lane towards Montague Expressway. Ms. Spuller stated this is in the long term [Valley] Transportation Plan.

Commissioner Briones stated the patches on Milpitas Blvd are really rough. He questioned if there were any more improvements.

Ms. Spuller discussed the loss of Redevelopment Agency funding and that would affect the City's Capitol Improvement Plan. The City is in a state of flux and figuring out what projects can be implemented.

Commissioner Briones asked if there could be additional enforcement of helmets. The Commission discussed writing a letter to the Chief of Police to request enforcing the helmet law.

Chair Stanojevic opened this item to the public.

Kristal Caidoy, 7 Homme Way, stated she is in support of a bicycle ride and more bike lanes in the City.
