A. Elections

Background: The Commission Bylaws require that a Chair and Vice Chair be selected annually at the first meeting of the calendar year. The Chair will call for meetings and preside over all sessions. In the absence of the Chair, the Vice Chair will preside.

Recommendation: Accept nominations and elect the Chair and Vice Chair for 2008.

B. National Night Out

National Night Out is a unique crime and drug prevention event where residents gather for a neighborhood block party to become better acquainted and make neighborhoods safer. National Night Out is a coordinated effort between police and community members to learn

better how to prevent crime in neighborhoods. This year marks the 24th annual National Night Out sponsored by the National Association of Town Watch. It is scheduled nationally on the first Tuesday in August. Since the Milpitas City Council meets on the first Tuesday of the month, and because members of the City Council have typically desired to attend neighborhood block parties, Milpitas' celebration of the event has usually been held on the following Thursday. This year that date would be August 7th.

The CAC will further discuss event organization and promotion at the May meeting.

Recommendation: Recommend the City Council select Thursday, August 7, 2008 as Milpitas' National Night Out.
