Presentation from Debra Whitlock-MCTV 26 Station Manager

At its meeting on January 6, 2010, the CAC expressed an interest in receiving a presentation from Debra Whitlock, MCTV 26 Station Manager on the type of community outreach and information which can be presented to the residents of Milpitas through the cable channel.

Staff has met with the Station Manager and provided the types of activities and events the CAC is annually involved with through its Work Plan.

Recommendation: Consider the Station Manager's presentation and discuss types of activities and events that would be appropriate for MCTV 29 community outreach to Milpitas residents.

National Night Out-August 3, 2010

National Night Out is a unique crime and drug prevention event where residents gather for a neighborhood block party to become better acquainted and make neighborhoods safer. National Night Out is a coordinated effort between police and community members to learn better how to prevent crime in neighborhoods. This year marks the 26th annual National Night Out sponsored by the National Association of Town Watch. It is scheduled nationally on the first Tuesday in August. This year that date would be August 3rd.

Once staff has obtained more details about the event from the Police Department, staff will report back to the CAC in May.
