1. September 2014 Monthly Report

Staff provided a summary of the monthly Information Services activities report for the month of September 2014.

Staff provided an update on the Wi-Fi Wireless Inc. review. Staff will be providing information and data to Wi-Fi Wireless Inc. regarding the City's light pole infrastructure and locations as well as power data for these locations. Staff will be meeting with Wi-Fi Wireless Inc. to determine its schedule for the 12 months in moving this project forward.

Staff also added that the ultimate goal for this project for Wi-Fi Wireless Inc. will be to provide and sell commercial access to high speed backhaul fiber locations to companies like AT&T and

Verizon as the demand for faster data connections for mobile devices continue to grow into new marketplaces and services.

Staff also reported that it is reviewing the design of the City's website to better accommodate mobile web application users. Staff will be interviewing all city departments to better address the level of information that can be provided on a new web design and for a mobile application. An added function will be to add more social media interaction with visitors to the City's website and mobile application.
