

RESOLUTION NO. 1

A RESOLUTION OF THE OVERSIGHT BOARD OF THE SUCCESSOR AGENCY TO THE FORMER MILPITAS REDEVELOPMENT AGENCY APPROVING AN ADMINISTRATIVE BUDGET FOR THE PERIOD JANUARY 1 TO JUNE 30, 2013

WHEREAS, Assembly Bill 1484, Statutes of 2012 ("AB 1484"), was passed by the California State Legislature and signed into law by the Governor; and

WHEREAS, AB 1484 provides for the payment of the administrative costs of the Successor Agency to the Former Milpitas Redevelopment Agency ("Successor Agency"), subject to the approval of the Oversight Board of the Successor Agency ("Oversight Board"); and

WHEREAS, the Successor Agency duly prepared and submitted an administrative budget for the period January 1 to June 30, 2013, in accordance with state law.

NOW, THEREFORE, the Oversight Board of the Successor Agency to the Former Milpitas Redevelopment Agency hereby finds, determines, and resolves as follows:

1. The Oversight Board has considered the full record before them, which may include but is not limited to such things as the staff report, testimony by staff and the public, and other materials and evidence submitted or provided to them. Furthermore, the recitals set forth above are found to be true and correct and are incorporated herein by reference.
2. In accordance with Health & Safety Code section 34171 et seq., the Administrative Budget attached as Exhibit 1 is hereby approved by the Oversight Board.

- (3) In FY 12-13, 4 FTE staff is allocated to Successor Agency. There are approximately 80 workers in the City Hall. As a result, approximately 5% of the utility costs is allocated to the Successor Agency
