- Please contact the Fire Prevention Division for fire water-line permit fees. Minimum charge is 3 hrs. (\$284/HR).
- Emergency Response Mapping Fee \$ 257.00 (new site - project)
- Standard charge per HR = \$284. For overtime per HR = \$333.
- There is a 3% (2.4% for >10K) process fee for credit card charges.
